INTRODUCTION

The KwaZulu-Natal province is one of the poorest provinces in the South Africa.

Statistics reflect the extremely high unemployment rate in the Province, with many families battling to survive. The other Provinces with the highest headcount of adult poverty are Limpopo (67,5%), Eastern Cape (67,3%), KwaZulu-Natal (60,7%) and North West (59,6%). For these four Provinces, significantly more than half of their population were living in poverty (Stats SA – 2019).

KwaZulu-Natal is in dire need of social welfare and skills development programmes in order to stimulate the economy, for business growth and to increase job creation opportunities.

BRIEF OUTLINE

The Humanity South Africa (Khidmatul Khalq Foundation) was formed in 2019 to assist the needy in areas of KwaZulu-Natal.

KHIDMAT is an Arabic word which means - To serve

KHALQ is an Arabic word which means - Humanity

Hence the English name of the organisation is

Humanity South Africa.

The organisation was established in 2019 by the Founder and Chairman, **Muhammad Masoom Bagdadi**, who had the passion to serve man-kind regardless of colour or creed.

Humanity South Africa is non-profit company registered in terms of the legislation of South Africa. It is registered in terms of the Non-profit Organisation Act, 1997. The Foundation was accredited by the Provincial Department of Co-operative Governance & Traditional Affairs (COGTA) as an NGO to provide essential services during the COVID-19 pandemic.

The Foundation is accredited with the Ethekewini Municipality Disaster Management and is also a member of the Minara Chamber of Commerce, Muslim Relief Alliance KwaZulu-Natal and affiliated to Muslims for Humanity.

To empower, educate and develop humanity.






OBJECTIVES

To undertake social welfare and humanitarian activities and these include, among others:

- To feed and provide humanitarian services to the most vulnerable and destitute when the need arises, regardless of the circumstances;
- To support education by providing nutritious meals to learners at schools in poorer communities;
- To provide financial aid and/or assistance to poor and indigent families;
- To promote and encourage the development and empowerment of the poor and unemployed, for them to be self-sufficient and self-empowered, thereby reducing poverty and promoting job creation;
- To provide primary health care education and awareness in poorer communities;
- To provide bursaries and scholarships to disadvantaged learners and students; and
- To provide boreholes in areas that are in dismal need of a water supply.



THE FOUNDATION'S FLAGSHIP OUTREACH PROGRAMMES

IN ORDER TO ACHIEVE THESE GOALS, THE FOLLOWING STRATEGIC INTERVENTIONS HAVE BEEN INITIATED:

1. SCHOOL NUTRITION PROGRAMME

Education in a number of schools are being supported through the provisioning of nutritious meals to learners, thereby improving their ability to attend schools, to be able to concentrate, Learn and perform to the best of their abilities.

2. FOOD HAMPERS

Disadvantaged families have been provided with grocery hampers to assist to sustain themselves and their families during difficult times, such as during the devastating floods in KwaZulu-Natal in 2022.

3. SKILLS DEVELOPMENT

The Foundation initiated a programme where women from the rural areas of the South Coast of KwaZulu-Natal are involved in the sewing of re-usable sanitary pads made from off-cuts fabric. This programme empowers the women in the rural areas, contributes to much needed job-creation and alleviates poverty in these areas.

4. PRIMARY HEALTH CARE EDUCATION

The Foundation is providing health care education and awareness to schools on an ongoing basis. Both disposable and re-usable sanitary pads are distributed to poorer areas in the province, thereby assisting to ensure the dignity of the girl learners in these areas.

5. HUMANITARIAN SERVICES

The most vulnerable and destitute communities receive humanitarian services from the Foundation, regardless of the situation or circumstances, and especially during a disaster. The Foundation was inundated with requests for assistance from families affected by the COVID-19 pandemic. Through proper administration, the Foundation ensured that the maximum number of families could be assisted during this extremely difficult time and they were provided with food and/or health packs, which included sanitisers, soap and masks.

6. WINTER WARMTH PROJECT


During the cold winter months, the Foundation provides blankets and warm clothing to the poor and desolated communities, especially in the rural areas. The Foundation also provides learners with winter uniforms such as jerseys and warm hoodies.

7. BOREHOLE PROJECT

The Foundation are currently in the process of providing much needed boreholes in areas where there is a dire need for water supply. As could be seen from previous similar projects, it is usually not only the recipient that benefits from the water supply, but also the community at large.

8. FOOD BANKS & FOOD GARDENS

The Foundation is currently exploring expansion in their outreach programmes to also include food banks. Food banks ensure communities have consistent access to the food they need. Food banks are paramount in solving the types of logistical problems faced at the root of the global hunger challenge. Food gardens have been started in Umbumbulu to self sustain the community.

The South African Revenue Service (SARS) would like to confirm that your application for exemption from income tax has been approved as it meets the requirements of a Public Benefit Organisation (PBO) set out in section 30(3) of the Income Tax Act No 58 of 1962 (the Act). Your Income Tax Exemption has been granted in terms of section 10(1)(cN) of the Act with effect from 22 March 2019. Annual receipts and accruals will therefore be subject to the provisions of section 10(1)(cN) of the Act and accruals and receipts from trading or business activities which fall outside the parameters of section 10(1)(cN) will be subject to tax.

The following exemptions also apply and are limited to:

1. The public benefit organisation has been approved for purposes of section 18A(1)(a) of the Act and donations to the organisation will be tax deductible in the hands of the donors in terms of and subject to the limitations prescribed in section 18A of the Act with effect from 28 October 2020.
2. Donations made to or by the PBO are exempt from Donations Tax in terms of section 56(1)(h) of the Income Tax Act.
3. Exemption from the payment of Estate Duty in terms of section 4(h) of the Estate Duty Act No.45 of 1955.
4. Exemption from payment of the Skills Development Levy (SDL) in terms of section 4(c) of the Skills Development Levies Act No. 9 of 1999.

In order to maintain your exempt status, the following conditions must be complied with:

1. When issuing a tax deductible receipt it must include the following information:
 - a) The reference number (the PBO number quoted on this letter).
 - b) The date of the receipt of the donation.
 - c) The name and address of the organisation issuing the receipt to which enquiries may be directed.
 - d) The name and address of the donor.

- e) The amount or nature of the donation if not in cash.
 - f) Certification that the receipt is issued for the purpose of section 18A and that the donation will be used exclusively for the activities which are approved for section 18A purposes.
 - g) The receipt must be issued in the year when the donation is received by the organisation approved for purposes of section 18A.
2. Furthermore, given the S18A approval granted, you must submit with your annual tax return, audit certificate stating that 18A funds for which 18A certificate were issued are utilised for 18A activities and supporting documentation which include the full particulars of all the receipts issued in respect of deductible donations and how these funds were spent.
 3. Submit an annual Income Tax Return (IT12EI) by the due date via SARS eFiling or manually. Your IT12EI can be obtained by
 - Registering online at www.sarsefiling.co.za to access, request and submit the IT12EI electronically
 - Calling the SARS Contact Centre on 0800 00 SARS (7277)
 - Requesting an IT12EI by contacting the TEU on teu@sars.gov.za or calling (012) 483 1700
 - Requesting an IT12EI by visiting your local SARS branch.
 4. Tax deductible receipts may only be issued for *bona fide* donations. Refer to Annexure A for more information in this regard.
 5. The exemption approval as contained in this letter is subject to review on an annual basis by the TEU upon receipt of annual income tax return and S18A supporting documentation.
 6. SARS must be informed in writing within 21 working days of any change in registered particulars (e.g. representative, change of name, address, trustee details, office bearers, etc.).








Distribution marketing participation in the securities market.

THE FUTURE OF HUMANITY SOUTH AFRICA

Our goal is to expand our operations to provide assistance to all disadvantaged people and communities throughout KwaZulu-Natal irrespective of race, gender or religion. One of the biggest expansions planned by the Foundation is the Food Bank concept.

The food bank model is simple but effective: Food banks partner with companies all along the supply chain to recover safe, wholesome food that would otherwise be discarded. The food is then distributed to community-based organisations for distribution to the most vulnerable families and communities. This model of food recovery and distribution provides communities with consistent access to food that is sufficient, safe and nutritious.

The cost estimation for the establishment of a food bank will be dependent on the area/community, availability of a suitable premises, and other costs, such as shelving, refrigerating, etc.

No single organisation or entity can solve the problem of global hunger alone. The face of poverty is universal and the need for poverty alleviation programmes is ever increasing.

This mammoth challenge requires cross-sectoral collaboration. It requires the concerted efforts of individuals and institutions—governments, multilateral agencies, companies, and civil society organisations.

In order for the Foundation to realise its goals and expansion projects, financial support is required to achieve a greater impact on the impoverished communities in South Africa. At present, the Foundation and its programmes are funded by business people and private individuals, selflessly contributing fund to the Foundation and its causes. Without them the Foundation would not have been able to achieve the impact it has had to date to assist the poorest of the poor communities in KwaZulu-Natal.


